Mission

Providing alternative social services for the reintegration of victims of trafficking in human beings and of young people at risk

Target Groups – Adult Victims of Trafficking in Human Beings and Their Families

- <u>Types of Exploitation</u>: sexual, labor, begging, constraint to committing felony, mixed;
- Gender: men and women;
 - ADPARE assists minors only within the family of origin.
- <u>Place of Exploitation</u>: both internal and external trafficking victims;

Experience – First Steps

- Four of the ADPARE founding members were actively involved in the implementation of the "Assistance Center for Victims of Trafficking" pilot project coordinated by IOM Mission in Romania in 2000, assisting 126 victims within one year;
- ADPARE was founded after the completion of the IOM
 Mission in Romania pilot project.

Working Method - Case Management

- CASE MANAGEMENT = integrated strategy of providing assistance services in an individualized manner to victims of trafficking in human beings;
- SPECIFIC TASKS for a VoT Case Manager:
 - 1. Linking the VoT to different types of services;
 - 2. Providing intensive reintegration services;
 - 3. Outreach to engage clients in services;
 - 4. Assessing individual needs;
 - 5. Prioritization of requisite support services;
 - 6. Monitoring the reintegration process;
 - 7. Advocating for the VoT's rights and entitlements.

Working Method – ADPARE Case Management

- Combines assertive community reintegration with intensive case management;
- Focuses on providing directly crisis intervention services shelter facilities, food supplies and clothing, psychological support, first aid with usual medication, etc;
- Links the VoT with other service providers for long-term assistance ID papers re-issue, school reinsertion and professional qualification, legal counseling and representation in court, medical investigations and treatment;
- Collaborates with a private lawyer for legal counseling and representation in court for both penal and civil causes;
- Collaborates with a private psychiatrist for psychiatric assessment, treatment and follow-up;

Working Method – ADPARE Case Management

- Collaborates with a private medical clinic for gynecological investigation and blood tests, with another private clinic for general and specific medical investigations and with a private dental clinic;
- Collaborates with the governmental partner for mediating the relationship with the authorities – mayor's office, state social service providers, school inspectorates, labor placement units, etc;
- Collaborates with the law enforcement units border police and anti-crime police – and with the prosecutor's office for issues related to the security of the VoT and the investigation process;
- Provides assistance services to the VoT including the family of origin, the extended family or the nuclear family;

Types of Assistance Services

- Material food and hygienic supplies, clothing, footwear, urban transportation;
- <u>Social</u> ID paper re-newel/issue, inter-urban transportation, mediation of the relation with the authorities, mediation of the relation with the law enforcement, mediation of the relation with the social services;
- <u>Psychological</u> preliminary assessment, individual psychotherapy, group psychotherapy (art-therapy, ergo-therapy, social skills, independent life, conflict management), support in specific contexts (courts, medical clinics, etc.), family and/or couple therapy;

Types of Assistance Services

- <u>Legal</u> juridical counseling, representation in court for both civil and penal causes;
- <u>Educational</u> school reinsertion, professional qualification, work equipment, books and manuals, school supplies;
- <u>Professional Reinsertion</u> CV completion, job interview preparation;
- <u>Residential</u> shelter facilities, state transit shelter referral, hotel transit accommodation;

GOOD PRACTICE

- F, 20 years old, rural;
- Type and period of exploitation: Sexual for 1 year;
- Age at recruitment date: 15 years old;
- Place of Exploitation: Kopletz, Germany;
- Date of referral: August 2006;
- Referred by: Solwodi Germany;
- Date of exit: September 2007;

- F, 22 years old, rural, Roma ethnic;
- Type and period of exploitation: Sexual for 1 ½ years;
- Age at recruitment date: 18 years old;
- Place of Exploitation: Essen, Germany;
- Referred by: IOM Mission in Germany;
- Date of referral: March 2007;
- Date of exit: October 2007;

Good vs Bad Experiences of Cooperation in the Reintegration of Romanian VoTs exploited in Germany

GOOD PRACTICE

- Assistance period: 13 months;
- Emergent assistance needs: airport assistance, psychological, medical, social, juridical, educational, material;
- Assistance services provided by ADPARE: airport assistance upon repatriation, psychological, medical, social, juridical counseling and escort in Germany for trial attendance in May 2007, educational, material;

- Assistance period: 8 months;
- Emergent assistance needs: residential, medical, psychological, material, social, professional;
- Assistance services provided by ADPARE: shelter assistance, medical emergency assistance starting with March 2007, psychological, material, social, professional reinsertion;

Good vs Bad Experiences of Cooperation in the Reintegration of Romanian VoTs exploited in Germany

GOOD PRACTICE

- Minor VoT;
- family of origin;
- Family economic status: poor without social facilities and aids;
- Traumatic first sexual
 Traumatic experience within the exploitation period;

- Adult Roma VoT;
- Good relationship between
 Difficult
 relationship the VoT and the VoT's between the VoT and the VoT's family of origin;
 - Family economic status: poor with social facilities and aids;
 - physical experiences within the exploitation period;

Good vs Bad Experiences of Cooperation in the Reintegration of Romanian VoTs exploited in Germany

GOOD PRACTICE

- Protected escort from Romania to Germany for testifying within the penal trial of trafficking in minors initiated by the German authorities ensured by the German and Romanian competent institutions;
- Training sessions of the transnational multidisciplinary RO-DE team with the aim of protecting the VoT in the German court of law;
- Coverage of travel expenses and accommodation expenses for the VoT and Romanian ADPARE case manager, and financial remuneration per day of stay in Germany from the German Government of 4 Euro/hour;
- Recovery of clothing and personal belongings from the traffickers by the German authorities.
- Favorable trial sentence: 7 years of detention for 1 trafficker and 5 years of detention for the other 4 trafficking offenders.

- Provision of long term emergency medical services in Germany and Romania: medical checkups and evaluations, hospitalizations, medical treatment;
- Medical diagnosis: LKW2 fracture produced by crushing; frontal pelvis ring fracture; frontal right pelvis ring fracture of the right sacral bone associated with ISG; coccyx fracture; right pillar tibia fracture;
- Other medical diagnosis: Pregnancy in the 3rd month of evolution;

Good vs Bad Experiences of Cooperation in the Reintegration of Romanian VoTs exploited in Germany

GOOD PRACTICE

- Special protection measures for minor THB VoTs adopted within the German Court Room:
- 1) VoT was put to testify facing other parts from the court room to avoid visual contact between the VoT and the traffickers;
- 2) German Office Lawyer counseling and representation in court;
- 3) Interventions of the judge in emotional critical moments for the VoT;
- 4) presence of the Romanian ADPARE case manager and Romanian German translator in the secret court session;

- Medical therapy proposed: 1) Design and insertion of a medical prosthetics for fixating the external right tibia and USS LWK1 on LWK3 through medical surgery in Germany; 2) Osteo-syntesis of the right tibia pillar in Germany; 3) Design of a medical corset necessary for the post-surgery recovery period to be worn for 2 months at least;
- Upon the VoT's repatriation in Romania, the German authorities due to the fact that the police trafficking investigative procedures finalized with no concrete result of initiating a penal trial against the trafficker, requested the coverage of the medical costs by the VoT, costs which summed up to thousands of Euros and that the VoT could not under any circumstances be able to pay.
